The Vendor specifically agrees to be open for business during the entire course of the festival. Festival operation is from 11 am to 11:30 pm, Sat. Sept. 21, 2024. SETUP **must occur** between 6 pm & 9 pm Fri., Sept 20, 2024, or 8 am and 10 am Sat., Sept. 21, 2024. Breakdown can occur on Sat. Sept. 21 after 10 pm or Sun., Sept. 22, 2024, from 9:30 am to 1:00 pm SETUP AND BREAKDOWN MAY ONLY OCCUR DURING THESE STATED TIME PERIODS. **Early dismantlement is not allowed under any circumstances.** All trash and debris must be cleared from vendor area at Festival close. Failure to properly clear grounds shall result in a \$25 cleanup fee.

Vendors assume the risk of rain, wind, lightning, or other weather-related elements on the days of the Greeley Irish Festival. Greeley Irish Festival expressly disclaims any obligation or representation related to the number of persons to be attending the festival, or the revenue to be derived there from.

Some items and/or materials are contrary to the INTENT OF Greeley Irish Festival and may not be marketed or offered under the auspices of the Greeley Irish Festival. Contact Greeley Irish Festival directly to review any political items or materials as to their eligibility if you have a question. Greeley Irish Festival reserves the right to deny any vendor the sale of or the distribution of any items or materials.
